	Asbestos Notification Statement.		
	Palm Beach County Health Department - Abandonment of Septic Tank (Note: A separate permit by a licensed plumbing contractor is required to disconnect and cap the sanitary sewer and/ or water service.		
	Extermination Certification Letter from a licensed Pest Control Operator (PCO) stating that all structures are rodent free.		
	Notice of Commencement for work valued at \$5,000 or more. (Recorded copy must be submitted to <a href="mailto:inspections@greenacresfl.gov">inspections@greenacresfl.gov</a> prior to scheduling the first inspection)		



## Required Plans and Documents (Continued...)

#### **NOTES:**

- It is the responsibility of the applicant to protect the storm water drainage system by installation of a silt fence along the property lines and wrapping and blocking all drainage system inlets in the vicinity of the property. Once the silt fence is in place, please call (561) 642-2059 to schedule an inspection.
- The contractor is responsible for scheduling a **pre-demolition** inspection prior to commencement of all work.
- The contractor is responsible for scheduling the final demolition inspection upon completion of all work.
- Zoning and Engineering approval is required for demolition of all structures. Prior to submitting your completed application, you shall first obtain all required releases.
- Additional documents may be requested at any time during the permitting process. Any exceptions must be approved by the Building Official.
